Likewise Deputy Labour Commissioner, Yamuna Nagar, Assistant Director, DIC, Yamuna Nagar & Assistant Director Industries & Safety shall ensure that no hardship shall occur to any worker who have been working in various establishments so far and they shall also ensure that relief/essential commodities should be reached to such families. They shall also ensure that those who have been registered with the Haryana Building and other Construction Worker's Welfare Board shall be provided a sum of Rs. 4500/- per month on weekly basis starting from 30th March 2020, directly into their respective bank accounts. They shall also send report regarding number of beneficiaries and amount paid to them daily at 4:00 PM in the office of undersigned and also sends the copy to Additional Deputy Commissioner, Yamuna Nagar.

Likewise DFSC, Yamuna Nagar shall ensure that ration shall be distributed to beneficiaries on priority basis. In so far as rural areas are concerned, DDPO Yamuna Nagar and concerned BDPOs may be contacted.
