ORDER UNDER SECTION 3 OF THE PUNJAB SMALL TOWNS PATROL, ACT, 1918

Whereas the W.H.O., Govt. of India and Govt. of Haryana has declared the recent novel Corona virus (COVID-19) epidemic as Public Health Emergency of International Concern, (PHEIC) to mitigate the risk of COVID-19, contact/gathering of people in large numbers need to be restricted.

In my opinion a situation has arisen in view of the internal security which necessitates the making of special measures with a view to avoid any mishap.

Whereas the inhabitants of the villages falling within the jurisdiction of Yamuna Nagar District have not voluntarily made sufficient provisions for watch and ward in their respective jurisdictive areas.

Now, therefore, I, Mukul Kumar, IAS, Deputy Commissioner, Yamuna Nagar in exercise of the powers conferred on me by virtue of section 3 of the Punjab Village and Small Towns patrol Act, 1918, do hereby, order and direct all Gram Panchayats to take order that all able bodied adult male inhabitants of all the villages in the district shall be liable to perform patrol duty during day and night time and shall ensure to avoid the gathering of people. It is further ordered and directed that all able bodied adult male inhabitants of the villages in district shall be liable to perform patrol duty in all the villages of the district during day and night.

The Gram panchayats constituted under the Haryana Panchayati Raj Act, 1994 of the villages shall be responsible for providing patrol and for ensuring the performance of patrolling as envisaged in terms of section 4 of the said Act of 1918. The District Development and Panchayat Officer, Yamuna Nagar will ensure the regulation of requisite patrol through village panchayats.

This order shall remain in force till further orders.
