ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Whereas the MHA Govt. of India, vide its order No. 40-3/2020-DM-1(A) dated 29-06-2020 has extended the lockdown for a period of 31 days w.e.f. 01st July, 2020, in Containment zones and issued new guidelines as annexed therewith on Unlock-2, I, Mukul Kumar, IAS, District Magistrate, Yamuna Nagar invoking the powers conferred under section 144 Cr.PC do hereby prohibit the following in Yamuna Nagar district in the interest of maintenance of public, health, hygiene and safety in view of the nCOVID-19 pandemic.

Movement of any individual whatsoever for non essential purposes shall henceforth remain restricted between 10:00PM to 05:00AM within the district, as well as movement outward the district with immediate effect till 31-07-2020 except for essential activities, including operation of industrial units in multiple shifts, movement of persons and goods on National and State Highways, loading and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains and airplanes. Persons above the age of 65, or having co-morbidities, suffering from chronic disease, pregnant women and children below the age of 10 years are advised not to come out in open except in the case of a medical emergency. These orders shall not be applicable on Police Officials and public servants on duty.

The compliance of this order shall be strictly enforced and ensured by all Executive Magistrates/Police officials on duty and any violation of the same shall be strictly dealt with as per sections of 188, 269 and 270 of the Indian Penal Code, 1860.

The order shall be promulgated by uploading it on the District website, circulated it through Whatsapp groups, and on their mediums of social/digital media, whenever the same is not possible through these methods, means of mass communication like radio, television may also be used and shall be promulgated in the area of district Yamuna Nagar by beat of drum, by announcement through the publicity of an of Public relation department.

In view of the requirement of the situation which has become emergent, this order is passed ex-

garte and addressed to the public at large.
