

# OFFICE OF DISTRICT MAGISTRATE, YAMUNA NAGAR

## ORDER

The world health organization has declared COVID 19 as global pandemic and the National Disaster Management Authority is satisfied that the country is threatened with the spread of COVID 19 epidemic and has considered it necessary to take effective measures to prevent its spread across the country. In compliance with the orders issued by Ministry of Home Affairs, Govt. of India Order No.40-3/2020-DM-1 (A) dated 29.06.2020 and State Disaster Management Authority, Govt. of Haryana Memo No. DMC-SPO-2020/7563 dated 30-06-2020, to extend Lockdown in Containment Zones up to 31-07-2020 and re-open prohibited activities in a phased manner in areas outside Containment Zone in the territorial jurisdiction of Haryana. Accordingly, to contain the transmission of nCOVID-19 disease, following orders under sections 30 and 34 of the Disaster Management Act, 2005 are hereby made to regulate the operations of the activities in the territorial jurisdiction of the district Yamuna Nagar.

The following activities shall continue to remain prohibited till further orders.

- i. All cinema halls, gymnasiums, swimming pools, entertainment parks, theatres, bars and auditoriums, assembly halls and similar places.
- ii. All schools, Colleges, educational/ coaching institutions will remain closed till 31-07-2020. However, online/distance learning shall continue to be permitted and shall be encouraged.  
Training Institutions of the Central and State Governments will be allowed to function from 15-07-2020 for which standard Operating Procedure will be issued by the Department of Personal & Training (DoPT).
- iii. International Air Travel of Passengers, except as permitted by MHA.
- iv. Social / Political / Sports / Academic / Cultural / Religious functions and other large congregations.

**However, lockdown shall continue to remain in force in Containment Zones till 31<sup>st</sup> July 2020**

As per National Directives for nCOVID-19 management, the following are the lockdown measures to be complied by public:-

- i. Wearing of face cover is compulsory in public places, work places and during transport.
- ii. Social distancing norms and staggered working/business hours will be followed in offices, workplaces, shops, markets, industrial & commercial establishments.
- iii. Provision for thermal scanning, hand wash and sanitizer preferably with touch free mechanism will be made at all entry and exit points and common areas.
- iv. Frequent sanitization of entire workplace, common facilities and all points which come into human contact e.g. door handles etc., shall be ensured, including between shifts.
- v. Persons above 65 years of age, persons with co-morbidities, pregnant women and children below the age of 10 years are advised to stay at home, except for meeting essential requirements and for health purposes.
- vi. Marriages related gatherings shall ensure social distancing and the maximum number of guests allowed shall not be more than 50.
- vii. Funeral/last rites related gatherings shall ensure social distancing, and the maximum numbers allowed shall not be more than 20.
- viii. Spitting in public places shall be punishable with fine and consumption of liquor, paan, gutkha, tobacco etc. in public places is not allowed.

- ix. Public is advised to install the **Arogya Setu mobile App** on their mobile phone and regularly update their health status on the same.

All establishments shall ensure permanent paint marking outside and inside their premises. These marks shall be made 1meter apart and it shall be ensured that persons visiting and working maintain social distancing by means of those marks. They shall also ensure that no vehicle is parked outside their shops so as to allow enough space for people to stand as per markings.

All the concerned are hereby ordered to comply with the directions above. Any violation of these instructions/orders is liable to criminal prosecution under section 51 to 60 of Disaster Management Act, 2005.
