## ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Whereas vide Additional Chief Secretary to Govt. of Haryana, Home, Jail, Criminal Investigation and Administration of Justice Department, D.O. No. PS/ACS Home/Spl. 153 dated 04-07-2020, in view of the prevailing COVID-19 pandemic, it has been decided not to allow "Kanwariyas" to proceed on "Kanwariya Yatras" on the eve of Maha Shivaratri during the Shravan month this year as the government of Uttarakhand, Uttar Pradesh have conveyed their inability to make arrangements for their transit/Stay.

I, Mukul Kumar, IAS, District Magistrate, Yamuna Nagar invoking the powers conferred under section 144 Cr.PC do hereby prohibit the "Kanwariyas" to proceed on "Kanwariya Yatras" on the eve of Maha Shivaratri during the Shravan month this year in District Yamuna Nagar in the interest of maintenance of public, health, hygiene and safety in view of the nCOVID-19 pandemic.

The Superintendent of Police, Yamuna Nagar, all Sub Divisional Magistrates, all Executive Magistrates, all Deputy Superintendent of Police and all SHO's shall be responsible for enforcement of above prohibitory orders in its letter and sprit. The compliance of this order shall be strictly enforced and ensured by all Executive Magistrates/Police officials on duty and any violation of the same shall be strictly dealt with as per sections of 188, 269 and 270 of the Indian Penal Code, 1860. These orders shall not be applicable on Police Officials and Public Servants on duty.

The order shall be promulgated by uploading it on the District website, circulated it through Whats app groups, and on their mediums of social/digital media, whenever the same is not possible through these methods, means of mass communication like radio, television may also be used and shall be promulgated in the area of district Yamuna Nagar by beat of drum, by announcement through the publicity van of Public relation department.

In view of the requirement of the situation which has become emergent, this order is passed ex-pare and is addressed to the public at large.
