ORDER


In continuation of this office order No.1435/MA dated 31.03.2020 the buildings of the Radha Swami Satsang Bhawan and Sant Nirankari Satsang Bhawan situated in the different locations of the District Yamuna Nagar were identified and declared as place for accommodation of the migrant labourers.

The buildings of following Radha Swami Satsang Bhawans are also declared as shelter homes for accommodation of stranded labourers in addition to those declared earlier vide order under reference. All requisite facilities, as desired by the Government be also provided to them with the assistance of volunteers and NGOs.


1. SP, Yamuna Nagar will provide security in all such relief camps, so that stranded labourers do not run away from shelter homes.
2. ADC Yamuna Nagar will be Overall incharge of the above mentioned purpose.
3. SDMs will be the incharge for their respective Sub Divisions and ensure that Nodal Officers report through link i.e bit.ly/sheltercamps at 12:00 noon and 8:00 PM daily.
4. Civil Surgeon, Yamuna Nagar shall ensure medical checkup of migrant labourers in above stated accommodations in accordance with the Medical Protocol (COVID-19), which include screening, medical checkup and quarantine.
5. Duty Magistrates designated as Incident Commanders vide letter no. 171-186/PO/FRA dated 25-03-2020 of above mentioned locations will assist the controlling officers cum Nodal Officers of their respective areas and shall maintain law and order at such centers.
