<u>ORDER</u>

In continuation to this office order Endst. No. 2120/ MA dated 20-05-2020 and in compliance orders issued by Additional Chief Secretary to Govt. of Haryana, Urban Local Bodies Department, Chandigarh Memo. No. ADULB/Admn/2020/29028 Dated 22-05-2020 & 29054 dated 23-05-2020 following modifications/relaxations is hereby done:-

- Stationary & Book shops, Auto spare parts shops and Authorized Rail E-tickting centres shall remain open from Monday to Saturday between 9:00 AM to 6:00 PM.
- 2. Marriage/ Banquet halls are allowed to open with following advisory :
 - a. A maximum number of 50 guests at any time are allowed to attend a function and prior permission for the event shall be obtained from concerned Sub Divisional Magistrate.
 - b. Sanitization and thermal screening of all persons shall be conducted at entrance of venue and if any person found fever (37.5 C/99.5 F), cold, cough, and difficulty in breathing shall not be allowed to enter in the premises and immediately be referred to COVID, Hospital, ESI, Jagadhri.
 - c. Food handlers shall wear gloves during the marriage function and Marriage/Banquet halls owner shall ensure disinfection of halls after every such function.
 - d. Wearing of facemask is compulsory for guests and staff and one meter distance shall be maintained by all persons.
 - e. No person shall be allowed from containment zone.
 - f. Every Marriage halls must have adequate space and hygienic with hand wash facility with soap & water at washrooms. No central air conditioner is allowed to use.
 - g. Spitting and consumption of liquor, Paan, Gutkha and Tobacco in public places is strictly prohibited.
 - h. A nodal person shall be appointed by the Marriage/Banquet hall owner to oversee the overall arrangement at the venue. He will make a list of guests with their contact details and ensure that every person download Aarogya setu app.

3. Barber shops/saloons/Beauty parlors etc. shall provide services as per following advisory.

- i. Wearing of facemasks, head cover and apron is compulsory for every client and staff.
- ii. Clients from Containment Zone shall not be allowed . Date wise record of identity of all client along with address and mobile numbers be maintained, so that they can be contacted easily, if needed.
- iii. Hand sanitizers shall be made available at entry point, staff should sanitize their hands after every haircut/Shave etc.
- iv. Token system shall be adopted and adequate spacing (one meter) shall be maintained for sitting.
- v. All equipments and combs shall be sterilized appropriately after each use on a client. It is advised to have multiple sets while one set is disinfected , other can be used.
- vi. Due to close contact corona can infect eyes too. Hence, staff should use plain goggles or faceshields or triple layers surgical mask, head cover, arpon and wear gloves.
- vii. Frequently touched places such as floor, lift, lounge area, stair case and hand rails must be disinfected with 1% Sodium Hypochlorite twice a day.
- viii. Sharp waste such as blades, disposable razors shall be collected in puncture-cumleak proof white containers having 1% Sodium Hypochlorite and once it is 3/4th filled, shall be handed over to Bio hazardous waste disposal agency designated by Municipalities for its further disposal.
- ix. All staff shall be educated to use facemask and practice cough etiquette and posters for the same shall be displayed at the entrance.
 x. No client /staff with UL (influence bit) is a start of the same shall be displayed at the entrance.
- x. No client /staff with ILI (influenza like illness) be allowed inside and shall be immediately referred to COVID Hospital, ESI, Jagadhri.
