DISTRICT ADMINISTRATION, YAMUNA NAGAR

ORDER

As a Corona positive case has been detected in the Bada Jain Mandir locality of Municipal Committee Sadhaura area. Therefore, part of Bada Jain Mandir locality (as attached in Annexure 'A') is hereby declared as the Containment zone and the rest of the Bada Jain Mandir locality is declared as Buffer zone, for all the purposes and objectives as prescribed in the protocol of nCOVID19 to prevent its spread in the adjoining areas.

In order to combat the above mentioned situation, the following action plan is adopted to carry out the screening of the suspects, testing of all suspected cases, quarantine, isolation, social distancing and other public health measures in the containment zone effectively.

Sufficient number of teams shall be deployed to carry out door to door screening/
thermal scanning of each and every person of all the households falling in the
containment zone, by the Civil Surgeon, Yamuna Nagar. All of them would work under
strict directions of the Civil Surgeon, Yamuna Nagar. All the staff shall be provided with
Personal Protective Equipments and other required devices for screening/thermal
scanning etc.

(Action by: Civil Surgeon, Yamuna Nagar)

2. Sanitisation of all areas of the containment and buffer zone shall be ensured by the Secretary, Municipal Committee Sadhaura, as per nCOVID 19 guidelines. Gates/door knobs of each and every household shall also be properly sanitised. Proper lifting and transportation of Solid waste shall be done. The deployed staff should be provided with Personal Protective Equipments viz. face masks, gloves, caps, sanitizers, shoes and they should also be directed to follow social distancing norms.

(Action by: Secretary, Municipal Committee, Sadhaura)

3. Movement of every person, except those deputed on COVID 19 duty, shall be absolutely restricted and the entire containment zone shall be sealed by setting up adequate nakas and deployment of enough police force. A proper record of entry/exit of personnel should be maintained by the police.

(Action by: Superintendent of Police, Yamuna Nagar)

 Necessary barricading of the Containment as well as the Buffer zone shall be done by the Executive Engineer, PWD (B&R) Naraingarh in consultation with Superintendent of Police, Yamuna Nagar.

 A dedicated control room shall be set up in the Sub-Tehsil office, Sadhaura. Naib Tehsildar, Sadhaura shall be in-charge of this control room. He shall be supported by Civil Surgeon Yamuna Nagar.

(Action by: Naib Tehsildar, Sadhaura and Civil Surgeon Yamuna Nagar)

 Sufficient stock of PPEs Personal Protective Equipments viz. face masks, gloves, caps, sanitizers, shoes/relevant devices/required medicines shall be kept by the Civil Surgeon at the dedicated control room set up at Sub-Tehsil office, Sadhaura.

(Action by: Civil Surgeon, Yamuna Nagar)

 ESI hospital is declared as containment/Isolation facility/COVID19 Hospital. Civil Surgeon, Yamuna Nagar shall ensure that all required health-care/medical facilities are in place to meet any emergency.

(Action by: Civil Surgeon, Yamuna Nagar)

8. Essential activities like supply of goods such as raw-ration/milk/groceries/medicines/vegetables/fruits etc. shall be allowed in the area. The related shops of the area can home-deliver the commodities, given that the delivery personnel will wear PPE and drop the packets at the door itself. He/she will not go inside any house or make physical contact with any person. The rates of all essential commodities should be monitored to ensure smooth supply to all the residents.

 Regular power supply in the Containment and Buffer zone shall be ensured by SE, UHBVN Yamuna Nagar,

 Regular safe drinking water supply shall be ensured by the Executive Engineer, Public Health Department Naraingarh.

(Action by: Executive Engineer, Public Health Department Naraingarh)

11. Regular telecom services shall be ensured by DGM BSNL Yamuna Nagar-

 Ambulances and other para-medical staff shall be deployed by the Civil Surgeon, Yamuna Nagar.

The **Sub-Divisional Magistrate Bilaspur** shall be the overall in-charge of the containment/buffer zone and to over-see all the arrangements.

All the officers/officials on duty shall perform/discharge their duties efficiently and any laxity on the part of any officer/official will attract strict action under the provisions of Disaster Management Act, 2005.
