

Subject: Decision of the Meeting held on 30.03.2020 at 3.30 P.M. through Video Conferencing under the Chairmanship of Hon'ble Mr. Justice Rajiv Sharma, Judge, Punjab and Haryana High Court, Chandigarh and Executive Chairman, Haryana, State Legal Services Authority, Panchkula.

Agenda: Effective implementation of the directions issued by Hon'ble Supreme Court of India on 23.03.2020 in Suo Motu Writ Petition (Civil) No. 1/2020-in RE: Contagion of Covid-19.

It was noted in today's meeting that due to the lockdown orders imposed all over the state of Haryana, the Committee felt that it is imperative to facilitate the process of grant of parole at the prisons itself.

As grant of parole requires execution of a Surety Bond, it was decided that all Deputy Commissioners/ District Magistrates shall depute an empowered Executive Magistrate at all the jails located in their jurisdiction. These Executive Magistrates shall be available every day at the jail till all such cases have been dealt with. The deputed Executive Magistrate shall process all the Surety Bonds at the jail premises itself.

All Deputy Commissioners/District Magistrates may ensure immediate compliance of the same immediately.
