No. ADULB/Admn/2020/26418 Dated 03-05-2020 & Ministry of Home Affairs letter no. 40-3/2020-DM-I(A) dated 01-05-2020 and in exercise of power conferred under section 30(2)(iv) of the Disaster Management Act, 2005. I, Mukul Kumar, IAS, District Magistrate Yamuna Nagar do hereby order for District Yamuna Nagar as under:-

All kind of Shops within district Yamuna Nagar shall remain open for general public between **08:00 AM to 04:00 PM** subject to the condition that social distancing shall be ensured through adequate gaps, wearing of masks is compulsory and shall not allow more than 5 customers/visitors at any point of time.

In addition to above mentioned instructions, the following activities will be allowed to

run/ operate in District Yamuna Nagar as per schedule prescribed below:-

4.	All eateries, restaurants, sweet shops etc will not be allowed to provide sit and dine in services to general public. They are allowed only for home deliveries and take away purposes. They are directed not to allow more than 5 customers/visitors at any point of time.	08.00 AM to 4.00 PM.
5.	All chemist shops, emergency OPDs of registered medical establishments and petrol pumps shall remain open	24 Hours
Note	 I. Wearing of masks/face cover is compulsory both for the shopkeepers and the customers. II. Social-distancing norms shall be followed for which marking at 6 ft. gap be done in front of the every shop. III. Hand-Sanitization facility must be available at the shop. IV. Shops counters/desks/chairs should be sanitized twice a day. V. There shall be no parking of vehicles in front of the shops. VI. No Shop-keeper will put any products/items/objects outside his shop. VII. All Shops, except medical stores and milk/ dairy shops shall remain closed on Sunday. VIII. There shall be not more than five person in the shop (including shopkeeper and helpers) at a time. IX. It shall be responsibility of the shopkeeper concerned to ensure compliance. If contravenes, necessary action shall be initiated against him. X. All shopkeepers shall download Aarogaya Setu App in their mobiles and all in the mobiles of all customers compulsorily. XI. Spitting in public place shall be punishable with fine. 	

The Retail Liquor vends shall be opened from 7.00AM to 7.00PM Every Sunday shall be observed as Holiday.

It is further clarified that all cinema hall shopping malls, religious places, gymnasiums, sports complexes, swimming pools, entertainment parks, theatres, bars and auditoriums, Hotels, Restaurant, Assembly Halls and similar places shall remain closed till further orders.

Violation of this order is punishable under section 188 of the IPC, under section 381 of Haryana Municipal Corporation Act, 1994 & under section 233 of Haryana Municipal Act, 1973 and other relevant provisions of Disaster Management Act, 2005.

This order shall be promulgated in the area of District Yamuna Nagar (except for the areas declared as containment zones by this office) by beat of drum, by announcement through the publicity value of Public Relations Department and by means of mass communication like Radio, elevision etc.
