ORDER

In continuation to this office order Endst. No. 2062/MA dated, 17-05-2020 & In Compliance of the Instructions issued by Government, the following buildings situated in District Yamuna Nagar have also been identified and declared as place of accommodation for the migrant labourers. These places are declared as shelter homes for accommodation of migrant labourers. All requisite facilities, as desired by the Government shall also be provided to migrant labourers with the assistance of volunteers and NGOs. The Supervisory officers are also directed to depute their own staff with the computer system at the shelter home allotted to them for the preparation of list of stranded labourers.

1. SP, Yamuna Nagar will provide security in all such relief camp, so that stranded labourers do not run away from shelter homes.
2. ADC, Yamuna Nagar will be Overall In-charge for the above mentioned purpose.
3. Civil Surgeon, Yamuna Nagar shall ensure medical checkup of migrant labourers in above stated accommodations in accordance with the Medical Protocol (COVID-19), which includes screening medical checkup and quarantine.
4. Duty Magistrates designated as Incident Commanders vide letter No. 171-186/PO/FRA dated 25-03-2020 of above mentioned locations shall assist the Duty Magistrates-cum-Supervisory officer of their respective areas and shall maintain law and order at such centers.
