1. SP, Yamuna Nagar shall ensure police deployment for law & order in all such relief camps and ensure that stranded labour do not run away from these shelter homes.
2. ADC Yamuna Nagar will be overall incharge of the above mentioned purpose.
3. SDMs would be the incharge for their respective Sub Divisions and ensure that that Nodal Officers report of through following link: [bit.ly/sheltercamps](https://bit.ly/sheltercamps) at 12:00 Noon and 8:00 PM daily.

4. Civil Surgeon, Yamuna Nagar would ensure Medical Checkup of such workers in accordance with the Medical Protocol (COVID-19), which would include screening, Medical Checkup and Quarantine.
5. Duty Magistrates designated as Incident Commander vide letter no 171-186/PO/FRA dated 25-03-2020 of above mentioned locations will assist the controlling officers cum Nodal Officers of their respective areas and shall maintain law and order at such centers.
