

ORDER

In compliance of orders issued by Additional Chief Secretary to Govt. of Haryana, Urban Local Bodies Department, Chandigarh Memo. No. ADULB/Admn/2020/29612 Dated 31-05-2020, State Disaster Management Authority, Govt. of Haryana Memo No. DMC-SPO-2020/6123 dated 30-05-2020 & Ministry of Home Affairs letter no. 40-3/2020-DM-I(A) dated 30-05-2020 and in exercise of power conferred under section 30(2)(iv) of the Disaster Management Act, 2005. I, Mukul Kumar, IAS, District Magistrate, Yamuna Nagar do hereby order for District Yamuna Nagar as under:-

1. All Shops/ Commercial establishment within district Yamuna Nagar shall operate for general public between **09:00 AM to 07:00 PM**.
2. Food restaurants and food aggregators like Zomato, Swiggy etc. are permitted to operate kitchens for home delivery of food items. The upper time limit for operation of kitchen will be 08:00 PM and home delivery by all means must be completed before 08:30 PM to ensure that no delivery boy will be out on roads beyond 09:00PM. All standards of hygiene like wearing of masks, gloves, caps etc. are being followed while cooking food in such kitchens. It shall be ensured that kitchens staff or delivery boys are not having any illness or symptoms of cold and cough etc. The thermal scanning of staff on daily basis and regular medical checkup of all such staff be ensured by the owner. Delivery boys shall wear gloves and masks during home delivery. No signature/thumb impression of the customer shall be taken by them while delivering the items. Preferably online electronic mode of payment shall be ensured to avoid contact and to maintain social distancing.
3. Dairy & other Allied activities shall remain open between 06:00 AM to 08:00 PM.
4. The directions regarding barber shops, sweet shops and banquet/marriage halls will be remain in force as per this office Order No.2120/MA dated 20.05.2020 & 2183/MA dated 27-05-2020.
5. All chemist shops, emergency OPDs of registered medical establishments and petrol pumps are allowed to open round the clock.
6. The restrictions imposed in containment zones shall continue to remain in force as decided by District Administration, Yamuna Nagar till further orders.

These activities shall be permitted subject to following conditions:-

Note:-	<ol style="list-style-type: none">I. Movement of individuals for non essential purposes shall remain strictly prohibited between 09:00PM to 05:00 AM.II. Social-distancing norms shall be followed for which marking at 6 ft. gap be done in front of the every shop.III. Wearing of gloves & facemask is compulsory for the shopkeepers & they shall ensure that shops counters, desks, chairs, door handles & floors should be sanitize twice a day.IV. The guards at the entry point of shops of large size and AC Shops should be provided sanitizer and thermal scanner. Shop owner shall ensure that no customers shall be allowed to enter the shop without thermal scanner, sanitization and mask.V. The customers/visitors should wear masks and be asked to stand in queue at a distance of minimum 6 feet. Proper marking of circles at the required distance should be done on regular basis so that customers/ visitors shall wait for their turn.VI. There shall be no parking of vehicles in front of the shops.VII. Preferably one member of family is requested to visit these markets areas to avoid overcrowding.VIII. Municipal staff shall clean and sanitize such market areas twice a day and spitting in public place shall be strictly punishable with fine.IX. All shopkeepers shall display public notice outside their shops to motivate customers regarding downloading of Aarogya Setu Mobile App and ensure that all their employees install said app in their mobile phones and use the same regularly.

It is further clarified that all cinema hall shopping malls, religious places, gymnasiums, swimming pools, entertainment parks, theatres, bars and auditoriums, Hotels, restaurants, Assembly Halls and similar places shall remain closed till further orders.

This order shall come in to force with effect from 01-06-2020.

Superintendent of Police, Yamuna Nagar, Commissioner Municipal Corporation, Yamuna Nagar, all SDMs, Duty Magistrates, SHOs, Secretary, Municipal Committees, Radaur and Sadhaura shall ensure strict implementation of this order. Violation of this order is punishable under section 188 of the IPC, under section 381 of Haryana Municipal Corporation Act, 1994 & under section 233 of Haryana Municipal Act, 1973.

All Municipalities shall publicize these guidelines amongst the shopkeepers/rehriwalas/fruit & vegetable vendors etc. for their awareness about maintaining social distancing and shall ensure to arrange for wide publicity by MUNADI on its own vehicles being used for door-to-door garbage collection vehicles having Public Address System(PAS)facility or by hiring vehicles for this purpose today itself on priority basis.

This order shall be promulgated in the area of District Yamuna Nagar (except for the areas declared as containment zones by this office) by beat of drum, by announcement through the publicity van of Public Relations Department and by means of mass communication like Radio, television etc.
